Voting Instructions

- You need to be a 2023 Member of ICOM UK to vote.
- Individual members can each cast a vote. Institutional members need to nominate one representative to vote on behalf of the institution.
- Each individual member or institution representative can cast one vote for each committee position available.
- Where only one candidate is standing for a position, this is a simple YES or NO vote.
- Where more than one candidate is standing for a position, each individual or institutional representative can vote for **one candidate per position**.
- Votes can be cast in person at the online 2023 AGM on Friday 16 June or online by email before 10:00 (UK time) on Friday 16 June 2023. <u>Please choose only</u> one method of voting. If you vote by email, you cannot vote again at the AGM.
- To vote by email, send an email to wk.icom.museum@gmail.com before 10:00
 (UK time) on Friday 16 June. In the email subject line write 'ICOM UK AGM Vote' plus your ICOM membership number (you can find this on your ICOM card or in your online ICOM account). In the body of the email, please state your voting preference for each membership position available.
