3. Co-Chair's Report, Strategic Plan and Forward Plan

CB took the opportunity to thank Dana Andrew and Louise Bevan for ten years of service to ICOM UK in the roles of Director and Membership Administrator.

Thanks went out to the new administration team, Kate Arthurs, Interim Strategic Director, Katie Hardgrave, Membership and Administration Manager, and Jemma Jarman, Communications Assistant.

ICOM UK new strategy, is closely linked to ICOM's global mission and covers three connecting areas - ICOM programmes, offering value to ICOM UK members, and managing ICOM's interests.

Thanks were given to ICOM UK's membership for taking part in the recent survey. Results show at least 75% of respondents see our new strategy as fitting well with their own goals and priorities, including the programme focus on heritage protection, decolonisation and environmental sustainability.

The strategy covers the period of 2025-2030.

Moving forward, the Trustees will

- develop programmes and activities (which will include input from the members' survey).
- 2. explore and develop our sector partnerships.
- 3. complete a set of tasks related to governance and finance allowing the organisation to operate smoothly.
- 4. Refresh our communications to flow from the strategy and to respond to members' priorities.

Finally, thanks were given to our outgoing trustee, Jane Knowles, and to Jane Henderson, co-opted Wales representative.

Annual Accounts 2022/23	Abeer Eladany (AE) presented the Annual Report and Accounts, which have been examined independently by accountants, Counterculture, who reported that the accounts were kept as required by the 2006 Charities Act, the statements do accord with the records, the account complies with accounting requirements, and the statements comply with financial reporting standards.

7. Membership Update	CB highlighted another increase membership by more than 600, most of which was driven by increases in individual and student memberships.
	ICOM UK are proposing an increase in fees for the next membership year. Fees have not increased since 2018, and our costs have substantially increased together with our growing ambition this year.
	Feedback from our recent membership survey has given an indication of how the fee increase may be structured.
8. Bursaries Update	A new bursaries strategy will be created as part of the overall strategy 2025-2023 and budget 2023/4 and published over the summer, before the start of the new membership year in October.
	Increased membership fees (see above) will partly pay for an improved bursaries offer.
9. General questions from members	General questions were received from members.
	Georgiana Hone (GH) asked what the membership fee increases might be. CB replied this will be discussed over the coming months as part of the draft budget for next financial year.
	Mimi Waitzman (MW) asked if individual membership fees could be linked to income as fees can be a barrier to joining. CB replied that the membership fees

	structure is tied to ICOM and there is currently no option for this but it is something we can discuss. MW thanked the board for the regular news updates. GH welcomed ICOM UK weekly emails which she passes to her colleagues.
